




## Faculty Review of Open eTextbooks



- This book is not a match for the course we are evaluating. The first sentence of the Preface starts, "This book aims at fulfilling the curriculum requirement of the master's degree students of Microeconomics..."
- A quick review of the pages reveals this is indeed NOT a Principles of Microeconomics book that could be used in the class identified for this review.
- In other words, this book is an inappropriate choice for us to review as it is intended for a MUCH more advanced course.  
Therefore, I've given it an NA for each question in this section.

- I was not comfortable evaluating all aspects of instructional design for this book. However, with some hesitation, I decided to rate some questions in this area in order to provide a comparison with the other books we reviewed.
- On questions where I did assess the text, I have rated it at or below the others books.
- Bookboon.com (the distributor) does not appear to distribute ancillary materials.  
This book appears to have at least a reasonable instructional design for a M.A. level book otherwise, though again establishing this last conjecture is beyond the scope of the current project.
